Subject : Observance of Vigilance Awareness Week, 2019.

1. The Central Vigilance Commission has the mandate under the Central Vigilance Commission Act, 2003 to fight corruption and to ensure integrity in public administration. It is charged with monitoring all vigilance activities under the Central Government and various authorities in Central Government and organizations under it, in planning, reviewing their vigilance work, and initiating and systematic improvement. In addition, the Commission with its outreach activities also endeavours to create an awareness among the public, especially the private sector, about the impact of corruption on the economy.

2. Observance of Vigilance Awareness Week every year is part of the multi-pronged approach of the Commission where a key strategy is to encourage all stakeholders to participate in the prevention of and the fight against corruption and to raise public awareness regarding the existence, causes and gravity of and the threat posed by corruption. The Commission has decided that this year the Vigilance Awareness Week would be observed from 28<sup>th</sup> October to 2<sup>nd</sup> November, 2019 with the theme "Integrity - A way of life (ईमानदारी एक जीवन शैली)".

3. Corruption can be defined as a dishonourable unethical conduct by a person entrusted with a position of authority, either to obtain benefits for himself or for some other person, or a phenomenon affecting all stakeholders in a broad way on the entire country. It is a public evil and a national calamity. It is a social and economic cancer which has become a major threat to the nation's growth and development. Integrity is the most fundamental and essential quality of a person.

4. The Commission has decided to observe the Vigilance Awareness Week from 28<sup>th</sup> October to 2<sup>nd</sup> November, 2019 with the theme "Integrity - A way of life (ईमानदारी एक जीवन शैली)". It is requested that all Government departments, Ministries, Departments, etc. should observe the Vigilance Awareness Week in their respective offices.

5. The observance of the Vigilance Awareness Week would be a matter of responsibility of all Government departments, Ministries, Departments, etc. It is requested that all Government departments, Ministries, Departments, etc. should observe the Vigilance Awareness Week in their respective offices.
